	MS SPIVEY SAID SHE WANTED TO SPEAK TO AN OFFICER REGARDING HER HUSBAND WHO HAD LEFT HER THE DAY BEFORE. RO SPOKE WITH HER ABOUT HER PROBLEMS WITH HER HUSBAND. SHE SAID HER HUSBAND HAD THREATENED HER OVER THE TELEPHONE. RO REFERRED HER TO THE DOMESTIC VIOLENCE AND MAGISTRATE. AS RO WAS LEAVING MR SPIVEY WALKED UP IN THE BACK YARD. IT WAS OBVIOUS THAT HE HAD BEEN DRINKING HOWEVER HE WAS ABLE TO TALK AND ANSWER RO'S QUESTIONS. HE SAID HE HAD MOVED IN WITH HIS MOTHER AND BROTHER IN WINSTON SALEM THE DAY BEFORE. MRS SPIVEY SAID SHE WAS UNEASY WITH HIM STAYING THERE. RO OFFERED TO TRANSPORT HER TO A RELATIVE OR A SAFE LOCATION AT LEAST 3 OCCASIONS WHILE TALKING TO HER. SHE SAID SHE WANTED TO STAY. MR SPIVEY SAID HE WOULD NOT HARM HER AND HE ONLY WANTED TO TALK WITH HER TO TRY TO WORK THINGS OUT. SHE AGREED TO LET HIM STAY. RO LEFT BUT WAS CALLED BACK TO THE RESIDENCE 2 HOURS LATER. RO, DEPUTY HICKS AND DEPUTY WILLARD RESPONDED. MRS SPIVEY SAID HER HUSBAND HAD SHOT AN AKITA DOG THAT WAS PLACED AT HER RESIDENCE FOR TEMPORARY CARE BY AKITA RESCUE. SHE SAID HER HUSBAND TOLD HER "YOU ARE NEXT". AS DEPUTY WILLARD WAS TALKING TO MR SPIVEY RO WENT WITH MRS SPIVEY TO A DOG LOT LOCATED BEHIND THE RESIDENCE. RO FOUND THE DOG LAYING UNDER THE BUILDING THAT THE LOT WAS ATTACHED TO. THE DOG WAS SUFFERING FROM A WOUND TO THE MOUTH AND THROAT AREA. THE ANIMAL WAS ALIVE BUT APPEARED TO BE PARALYZED. SHE THEN LED RO TO ANOTHER BUILDING BESIDE THE DOG LOT AND LOCATED THE DBL BARRELED 20 GA SHOTGUN THAT SHE SAID MR SPIVEY USED TO SHOOT THE DOG WITH. RO SECURED THE WEAPON AND RETURNED TO THE HOUSE. RO HAD DEPUTY HICKS PLACE HANDCUFFS ON MR SPIVEY AND ARREST HIM. MR SPIVEY THEN BECAME VERBALLY ABUSIVE AND ATTEMPTED TO RESIST RO EFFORTS TO ESCORT HIM TO THE PATROL CAR. RO PLACED RO'S HAND ON HIS UPPER CHEST AND THROAT AREA AND PUSHED HIM TO THE WALL AND REGAINED
